#### From 610:

Take Zachary Lane and head south.

Turn right onto 95th Ave N to 96th Ave N.

Follow the road to the end of the buildings.

Cloud Nine is the last building closest to 610.

Note: GPS often takes people to the Park and Ride lot when coming from the east side of town (169/610).

To avoid that, once on Zachary Lane go west on 95th Ave. N (not 96th Ave N).

Go west on 95th Ave. N to 96th Ave. N (just before the school bus company) and turn right.

Follow the road as it turns east to the end of the row of buildings.

Cloud Nine is in the last building at the end closest to Hwy 610.
