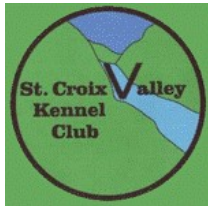

Turn left onto Bunker Lake Blvd
Turn left on Aberdeen
The show site is on the right

From the East

Take Bunker Lake Blvd (CR 116) west to Aberdeen St
Turn right on Aberdeen
The show site is on the right

From the West

Take Bunker Lake Blvd east.
Cross Highway 65
Aberdeen is the first left after crossing Highway 65
Turn left on Aberdeen
The show site is on the right
